O R D E R:

Government have decided to establish the Agriculture Advisory Boards at State, District and Mandal Level. The objectives of the Boards are as follows:-

- (1) Advise the departments of Agriculture including Horticulture and Sericulture to adopt their recommendations in crop diversification based on the market intelligence and Agro-climatic Zones.
- (2) Propose / Recommend the Government for providing support package in case of crop diversification.
- (3) Suggest and guide the departments to adopt best practices to improve the net farm income of the farmers.
- (4) Advise the departments in efficient utilisation of irrigation sources for improving the farm net income.
- (5) Advise in improving export facilities of Agriculture produce.
- (6) Ensure food security and improve the nutritional status of population in general and improving the net income of the farmer in particular.
- (7) Address the Domestic Demand and Supply gaps of Agricultural Commodities.

I. State Level:

- 1) Preparation of State Agriculture plan for implementation duly consolidating the district action plans.
- 2) Approval of District Agricultural Plans.
- 3) Guiding the districts in preparation & implementation of district Agricultural plans.
- 4) Coordination with the GOI and other States in improving the domestic as well as overseas exports of the Agriculture commodities.
- 5) Establishing the Market intelligence system at state level and advise the districts to adopt market driven cropping pattern in the districts.
- 6) Strengthening of policy decision system of the Government in implementation of various developmental and welfare programmes of the farming community.
- 7) Planning of the development of infrastructure facilities required for the farming community especially for the post harvest activities of the farmers.
- 8) Strengthening of the e-crop booking system.
- 9) Strengthening of regulatory and quality control systems of the Agricultural inputs.
- 10) State Committee will take advise from the Technical Committee constituted with the subject experts.

II. District level:

- 1) Preparation of District Agriculture plan for implementation duly consolidating the Mandal level action plans to be prepared based on the market intelligence and Agro climatic situations.
- 2) Approval of Mandal Agricultural Plans.
- 3) Guiding the Mandals in preparation & implementation of district Agricultural plans.
- 4) Monitoring the implementation of various developmental and welfare schemes in the district for the well being of farming community.
- 5) Ensure proper function of Rythu Bharosa Kendralu and serve the farming community to get all services at village level.
- 6) Monitoring of regulatory and quality control mechanisms being operated in the districts and to ensure pretested quality inputs are supplied to the farmers.
- 7) Monitoring of the e-crop booking system at District Level.

III. Mandal Level:

- 1) Preparation of Mandal Agriculture Plan based on the market intelligence and Agro climatic situations.
- 2) Getting approval of Mandal Agricultural Plan from the District.
- 3) Orientating the villages in preparation & implementation of Mandal Agricultural plans.
- 4) Monitoring the implementation of various developmental and welfare schemes in the Mandal for the well being of farming community.
- 5) Ensure proper function of Rythu Bharosa Kendralu and serve the farming community to get all services at village level.
- 6) Monitoring of regulatory and quality control mechanisms being operated in the Mandals and to ensure pretested quality inputs are supplied to the farmers.
- 7) Monitoring of the e-crop booking system at Village level.

NOTE:- Wherever Agriculture Plan mentioned above is the consolidated Action Plans of Agriculture, Horticulture & Sericulture Depts.
